

Town of Denning – Town Board Meeting

Meeting called to order at 7:06 p.m. by Supervisor Bruning,
Held on Tuesday, December 6, 2011 at the Town Hall.

Reading of last month's minutes by Deputy Town Clerk Carl Landon.
Motion to adopt and approve as read by Councilman Mike Dean, 2nd by Councilman Dave Brooks. All in favor. Motion carried by a 4 to 0 vote.

- NYMIR's insurance proposal is discussed.
- Emergency Water Reduction Program discussed things that FEMA may or may not cover.
- Supervisor Bruning informs the Board that he has spoken to County Executive Mike Hein regarding stream work.
- Cost of elections- may have 3 primaries plus the regular election also reads a letter from Board of Elections regarding the a possible move of the Primary date.

Highway Report by Superintendent Dan Van Sadlers

- Balace Bridge topped and blacktopped.
- FEMA has been around and is not receptive about work on the streams, (except for Clair Road).
- There is an appeals action to pursue.
- A temporary bridge has been put in on Frost Valley Road and Ulster County will plow – the Town will plow to Biscuit Brook.
- Loader fender reattached.

Town of Denning – Town Business Meeting

Held on Wednesday, December 13, 2011 at the Denning Town Hall.

Called to order at 7:03 p.m. by Supervisor Bruning

Minute book signed prior to the opening of the meeting.

The Supervisor presented the Budget vs. Actual for the month of November 2011.

Highway Vouchers presented (see Warrant # 12, voucher (#250-267)
Motion to approve and pay highway fund vouchers by Councilman Mike Dean, 2nd by Councilman Paul Schoonmaker, All in favor. Motion carried by a 4 to 0 vote.

General Vouchers presented, (see Warrant # 12, voucher (#247-286)
Motion to approve and pay general fund vouchers by Councilman Paul Schoonmaker, 2nd by Councilman Mike Dean, All in favor. Motion carried by a 4 to 0 vote.

Capital Vouchers presented, (see Warrant # 2, voucher (#9-17)
Motion to approve and pay general fund vouchers by Councilman David Brooks, 2nd by Councilman Kevin Smith, All in favor. Motion carried by a 4 to 0 vote.

Supervisor Bruning informs the Board that he will be writing a resolution to establish a Capital Project Fund for Peekamoose Road. It is an easier bookkeeping method and to carry funds over.

- Also Bill Rudge called today; the CWC has \$2.5 million for clearing woody debris from streams. He also said that New York State as well as the NRCS will contribute funds. He directs Highway Superintendent Van Saders to call get information and get on the list.
- Councilman Dave Brooks informs Superintendent Van Saders of a log-jam behind the Matero and Van Wagner's property.
- Supervisor Bruning comments the Town will get paid for the work it does.
- Brief discussion on stump grinding and obtaining permission from private property owners.
- Also included in the discussion; the use of private contractors.
- Councilman Dave Brooks asks Supervisor Bruning if he has spoken with Planner Dave Gilmour; response no, not last week.
- Councilman Mike Dean opens discussion on a moratorium of commercial construction in the hamlet district until the updated zoning is completed. Discussion follows briefly.
- Supervisor Bruning states that if something is not specifically mentioned in the current zoning you do need a Special Use Permit.
- Discussion on billing for Peekamoose Road and scope of work being done. Emergency protection work is being done and to repair the road.
- The road surface still needs to be done.

Motion to adjourn at 8:54 p.m. by Councilman Kevin Smith, 2nd by Councilman Mike Dean, All in favor. Motion carried by a 4 to 0 vote.
