Supervisor Brooks notes that UCRRA is still charging a fuel service charge.

Supervisor Brooks upon review of Judge Follender's voucher states he does not feel the Judge should prepay for his training and then wait 3 months for reimbursement. However if he does not attend and receive his training certification he must reimburse the Town.

Resolution No. 29 of 2015

WHEREAS New York State Town Highway Law § 141 authorizes the Town Board to transfer funds between highway accounts, and

WHEREAS the funds for the Stormwater Retrofit Program are placed in a separate account and are used solely for the maintenance of the storm water retrofit project, and

WHEREAS, Dan Van Saders Highway Superintendent has submitted the cost of maintenance on the Stormwater system for June 20th, 2014 at the total cost of \$327.76.

NOW THEREFORE BE IT RESOLVED that the Town Board HEREBY authorizes the Supervisor to transfer the sum of \$327.76 from DA231 Stormwater Retrofit Project Fund to reimburse the Highway Fund DA202 for the prior year expenses.

The Town Board reviews and accepts the proposed insurance policy from Mike Pries, Inc. Supervisor Brooks informs the Board that Dave Bodenstein has offered to address the Board.

Supervisor Brooks opens a discussion regarding a highway equipment purchase, remarking that Steve's truck has broken down. He asks the Town Boards opinion regarding the highway equipment purchase. He states he had wanted to have a pickup truck here and one in Sundown with the Highway Deputy Superintendent Totten for emergency use. However, the Town cannot purchase a new pickup, a 550 and a large truck. Discussion opened on a new truck or an older truck without a computer to be refurbished, 2 wheel vs. 4-wheel drive, to sell or trade Steve's truck. Supervisor Brooks comments we are talking about replacing our newest truck. Councilman Mike Dean comments that either way the truck must be repaired. Discussion on motors; Councilman Schoonmaker remarks the Cummings motor is a good one they have worked out the issues with it. Supervisor Brooks remarks that everyone he speaks with has issues with the newer trucks. Councilman Vurckio suggests placing a new bed on the other pick up and writing up the specifications for a new truck. Supervisor Brooks requests the Councilman Vurckio take the job on, he agrees. Councilman Schoonmaker comments we need the truck for the winter. The Town Board does not make a decision at this time; they will wait until repair report is submitted.

Discussion opened by Councilman Mike Dean, he informs the Town Board that Frost Valley YMCA has requested a bump sign on Denning Road by Erts Brook and the metal grate bridge. The Town Board agrees to the request.

Councilman Paul Schoonmaker opens a brief discussion on the Citizens for Local Power Program; green energy, he is unsure if it is practical here, he will do further research.

Motion to adjourn at 8:44 by Councilman Gregory Vurckio, 2nd by Councilman Mike Dean, All in favor. Motion carried 5 to 0 vote.
