**WHEREAS** the purpose of this article is to promote the health, safety, and general welfare of the inhabitants of the Town of Denning by proper regulation of parking and the abandonment of vehicles on roads and highways, located in the Town of Denning.

**WHEREAS** the Denning Town Board believes Local Law No. 1 of 2016 is in need of amending. And

**WHEREAS** a public hearing was held on April 4<sup>th</sup>, 2017 and any and all interested person(s) were heard at that time.
