**WHEREAS** Resolution No. 41 of 2017 was adopted by the Town of Denning Town Board titled: Local Law No. 3 of 2017, The Override of the Tax Levy Limit.

**NOW THEREFORE BE IT RESOLVED** that the Town of Denning Town Board **HEREBY RESCINDS** Resolution No. 41 of 2017.
